Minutes of the Meeting of the Special Full Council Meeting held in the Town Hall on Monday 14th February 2022.

283	Apologies for Absence: Cllrs, N Davey (Work) B Holdman (Sick), C Daw (away), T Lindus (Sick) and A Perris (Away). Resolved to accept the apologies.
284	Declarations of Interest under the Code of Conduct Cllr C Slade, MDDC cabinet member and Cllr D Knowles MDDC cabinet member, Cllr's W Burke, S Griggs, district councillors.
285	Minutes: To adopt the Minutes of the Council Meeting held on the 24th January as a true record. Resolved to accept the Minutes. The Mayor signed the Minutes.
286	Matters arising from the above There were no matters arising.
287	Democratic Period There were no members of the public in attendance.
288	Items recommended to be taken in Part B: The Town Clerk does not recommend any items on this agenda to be taken in Part B. All resolved to accept the recommendation.
289	To receive an assurance from the Proper Officer of the Town Council that the requisite number of elected members have requested the reversal of part of the motion in minute 275 of the minutes of the 24th January 2022 as laid down in the Standing Order 7A. The Town Clerk declared that he had received over the requisite number of 12 elected members, as there were a total of 13 councillor responses. Therefore the reversal could proceed.
290	Motions by Cllr D Knowles: a) That this council amends its decision of the 24th January 2022 to contribute £10,000 to Mid Devon District Council for the new CCTV Town System and substitutes the amount of £29,500. b) That Tiverton Town Council works in partnership with Mid Devon District Council to operate the CCTV Town System sharing the agreed costs on a 50/50 basis. c) That a group be set up comprising of members and officers of both Tiverton Town Council and Mid Devon District Council, together with representatives of the Devon and Cornwall Police to oversee the operation of the system and agreed costs associated with its operation, using, if possible any funding opportunities available. Cllr D Knowles read out the motion to the members. Cllr W Burke seconded the motion.

The Mayor concluded the meeting by updating the members on the planned forthcoming planning session open to all councillors and encouraged all to attend if they were able to.</p>
