## 234 Short Presentation on Sustainable Tiverton by Ms S Chapman & Ms C Groom

The Deputy Mayor Cllr A Hendy introduced Ms Chapman and Ms C Groom and gave a brief overview of what Sustainable Tiverton do.

Ms C Groom informed the members of who Sustainable Tiverton are and what they do. In terms of providing for the community, the group run the Community Fridge, Re-Rooted, the Repair Café and tree planting projects.

Ms C Groom explained that the group were in the early stages of establishing a club, Sustainable Tiverton had crowd funded for a Hub and had raised £5,000 from the community for this purpose. She said that they had been fortunate in winning the "Back to the Future Across Devon" competition and had been awarded another £5,000. This meant that the group had a total of £10,000 to help get the hub up and running. The purpose of a community hub was to provide a base where the public could source information on climate change, listen to talks, get involved in projects, test sustainable business ideas and also a base for Re-Rooted, the Repair Café and the "Give and Take" events.

Ms Chapman said that the group had been alerted to the availability of number 17 Market Walk as a temporary space for the hub. Amicus Health will be using the premises to the end of October 2021 as a temporary vaccination hub, so Sustainable Tiverton will initially take the window space and wall space for displays. In the interim, the group will carry out consultations with members of public and form a business plan and to raise some more funding. Ms Chapman said that Amicus were looking at some social prescribing and health and wellbeing/alcohol abuse groups. Ms Chapman said that it was an exciting project to be involved in.

Ms C Groom said similar projects had been set up around the country such as Cultivate Cornwall, who run "Text" which is involved with textile exchange and recycling, "Proper Job" in Chagford to reduce waste, create jobs, educate and support local businesses, which is the vision for Sustainability.

Ms Chapman said she would like the council's support and would welcome the member's suggestions and ideas and hoped that the group could work in partnership with the council. Ms Chapman concluded by thanking the council for the use of the Town Hall storage facilities for the Re-Rooted.

Cllr S Pugh thanked Ms Chapman & Ms Groom for their excellent presentation and exciting ideas which he felt the members will want to get behind. He asked if they were considering public engagement events.

They replied that they hoped that they could do this as they felt public engagement was very important. They have arranged with the CreaTiv Hub to display information. Going forward it was hoped to have face to face engagement with the easing of Covid-19 restrictions.

The first vote results were Mr J Lejeune 6, Mr P Hill 7, Mrs C Hole 3 and Mr A Walker 0. Mr Walker was then eliminated. The second vote results were Mr J Lejeune, Mr P Hill 7, and Mrs C Hole 3. Mrs C Hole was then eliminated. The Third vote results were Mr J Lejeune 7 and Mr P Hill 7. Three councillors decided to abstain, leaving 15 councillors to vote, meaning a majority of 9 was needed. The final result was Mr J Lejeune 6 and Mr P Hill 9. Mr P Hill was duly declared the successful candidate. The candidates were brought back into the main hall. The Mayor gave her congratulations to Cllr P Hill and declared him councillor. She thanked the other candidates for attending. 238 Correspondence The Town Clerk informed the members of the Tiverton Town Centre Partnership's plan to install bunting within the town centre in the near future.
