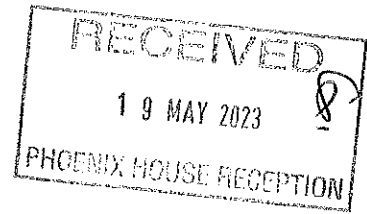

GENERAL NOTICE OF REGISTERABLE INTERESTS

I understand that in so doing I must declare any interest of my spouse or civil partner or of any person with whom I am living as a husband or wife or if we were civil partners in sections 1-6 of this form as set out in the Town/Parish Council's Code of Conduct for Members. The document will be retained for life of the Council (4 years) or the date of your resignation if earlier. Thereafter they are destroyed securely.
